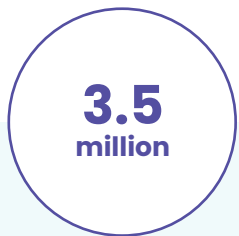

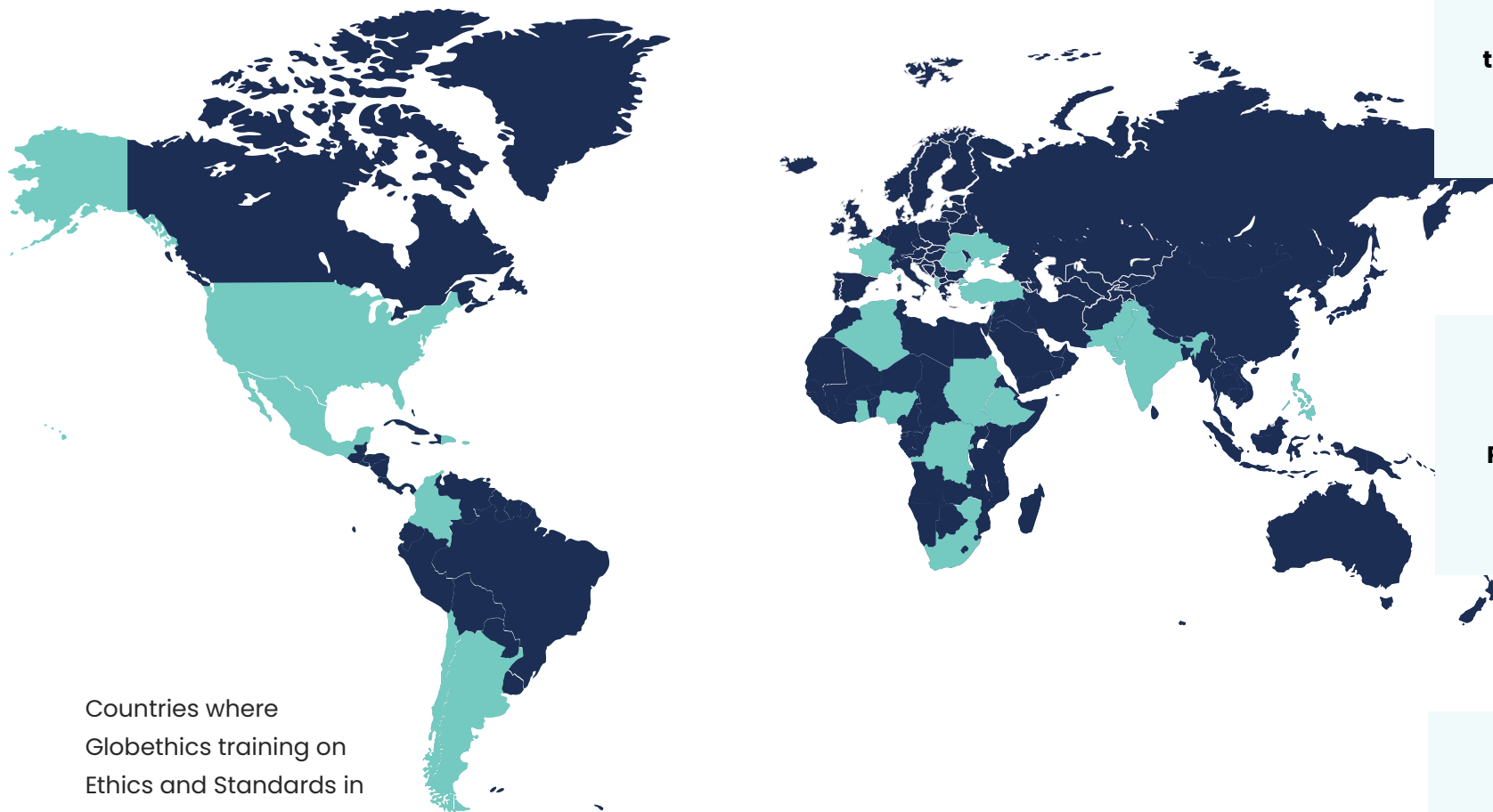

Challenges, opportunities and lessons learned

- Civil society organisations (CSOs) play a vital role in addressing ethical, societal, and environmental challenges arising from emerging AI applications. They have the potential to influence debates, policies, and practices shaping AI use and governance globally. Globethics will enhance cooperation with UNESCO, other stakeholders, and the emerging UNESCO Civil Society Organisations Repository for AI and Digital Ethics.
- While AI ethics became a hot topic in 2023, the discussion remained largely driven by industries and developed economies. Globethics has taken this urgent opportunity to catalyse discussions about possible solutions to harness AI for human dignity and human rights, leveraging broader, multilateral perspectives.

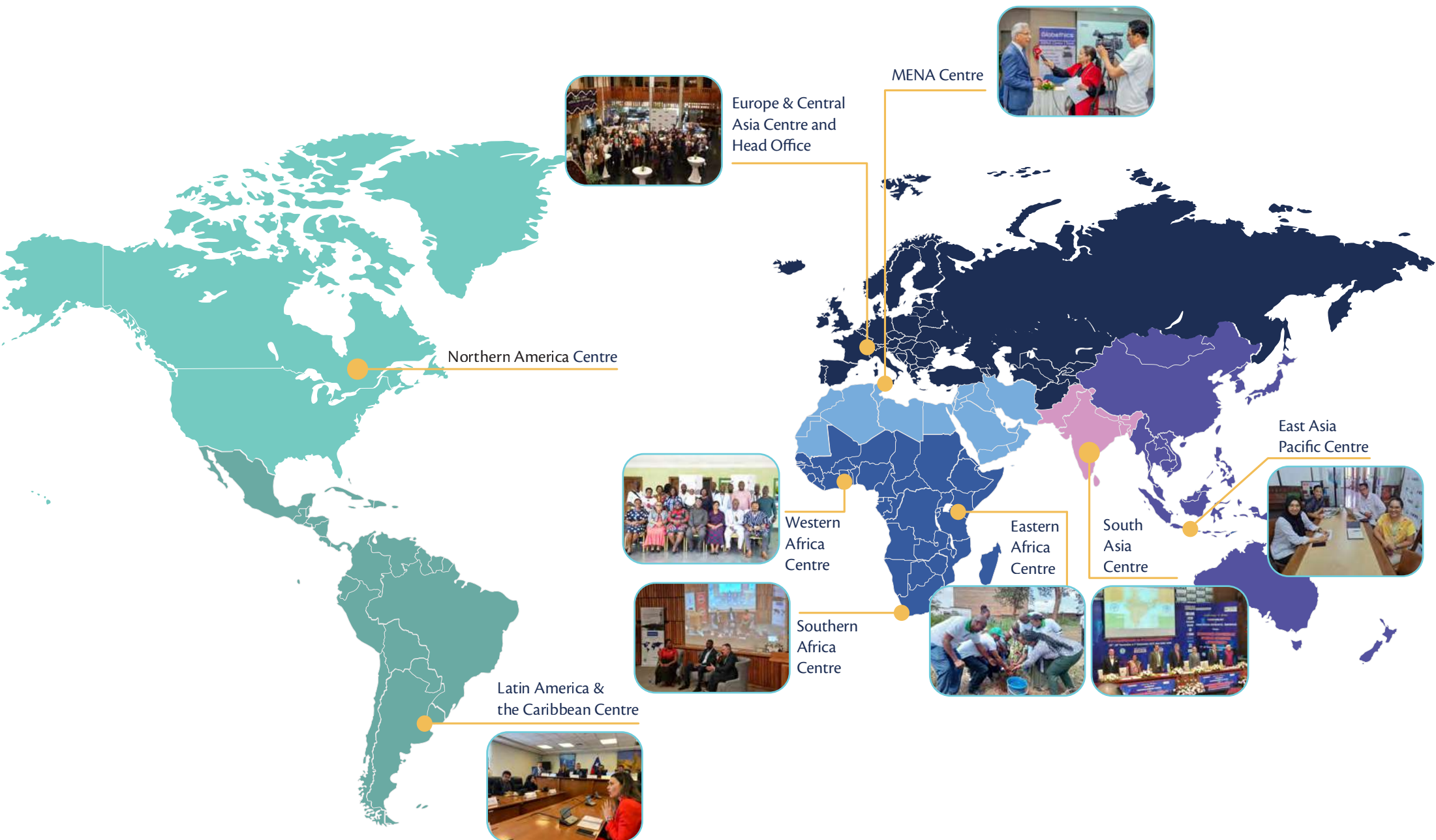

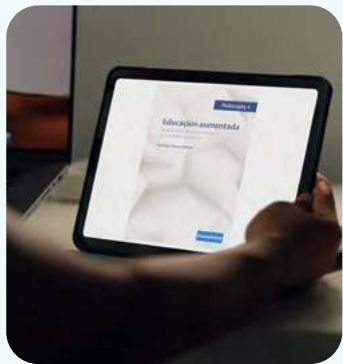

- Globethics will focus on enhancing inter-regional cooperation, synergies, and peer learning through our network and digital platforms.



Priority 6:

Transformative Impact

Building a results-based organisational culture

In 2023, an Impact, Innovation and Development (IID) Unit was established to measure and assess Globethics' transformative impact. To this end, the IID Unit developed the Monitoring, Evaluation, Accountability, and Learning (MEAL) system, with its 12 outcome indicators and 48 output indicators for the Strategic plan (2023-2027); implemented MEAL-related training for team capacity development, and delivered evidence-based mid-year and end-of-year MEAL reports, with the related lessons learned and adjustments measures.

Empowering Communication

Growing the global community of engaged ethical leaders

In 2023, a new wave of thought leadership surfaced from a younger generation of ethical leaders with the support of Globethics.

Young authors were given a platform to share their research globally through Globethics Publications, including Ruth Bekoung Siadous from Gabon, whose co-authored book titled *"Les prisons sont-elles utiles pour l'avenir de la société ? : droits de l'homme et milieu carcéral : le cas du Gabon,"* was recognised as a valuable resource by a wide audience, including government officials in Gabon.



During the COP28 Faith Pavilion session organised by Globethics, Keshoe Isaiah, a young indigenous Maasai environmental activist from Kenya, presented his insights on water ethics and the repercussions of the environmental crisis to an international audience. Globethics' multigenerational panel and AI experts' round table at Geneva Peace Week amplified the voices of emerging experts including Larissa Zutter, a youth leader and Senior AI Policy Advisor from Switzerland.

International Board of Foundation

The Globethics international Board of Foundation is the highest decision-making body of the organisation. Its members meet at least twice a year, serve on Board Committees and play an important in guiding the organisation’s global development, with their respective fields of expertise. The Board has four Committees:

1. Academic Committee

Ensures the academic quality of course programmes, advises on academic partnerships and accompanies the institutional and course programme accreditation processes and activities of the Globethics Academy;

2. Ethics and Compliance Committee

Oversees and safeguards the Code of Ethics and related policies and investigates and advises on potential and actual conflicts of interest and allegations of wrongdoing;

3. Finance Committee

Advises on and supports the financial stability and sustainability of the organisation; and

4. Recruitment Committee

Conducts the search for and selection of new members of the Board and of the Executive Committee to recommend to the Board for appointment.

Globethics reports to the Swiss Federal supervisory authority as a Foundation registered in Switzerland in accordance with the Swiss Civil Code Art 80 et seq.



Message from the President

Globethics: a global community of 'Diversity in Unity'

The year 2023 was a successful and important year for Globethics: it was the first year under the leadership of the new Executive Director Prof. Dr Fadi Daou and the first year of the new Strategy 2023-2027! This Annual Report shows the manifold activities and progress, especially in the restructuring of the regions, which takes time, and the new efforts for global policy. At the same time, previously established activities such as the global Library, the Publishing house, and the Academy continued with additional outreach.

As Founder and President, I am deeply grateful to see this global network not only growing, but growing with a spirit of diversity in unity and unity in diversity. Since the inception of Globethics in 2004, we envisioned a global community which is inclusive and centered around ethics. This often leads to an oppressive unity of a majority against minorities.

Globethics is such a vital and fascinating global community because the participants work together with the dream and commitment of 'diversity in unity' and 'unity in diversity'! Respecting the diversity of others while also being committed to individual identity and values - and respecting the unity in diversity: We all are humans with common and differentiated values. The values-driven orientation builds the roots of our unity. We are united with the common goal to contribute to a world of justice, peace, freedom and sustainability. I can only repeat my profound thanks to the Board, the leadership, the global team, the volunteers and the donors and all of you engaged on this journey!
