“Ethics helped me to change my life”

“I would probably still be working as a manager in a global company earning a lot of money and being unhappy because I was forced to do things against my principles if it were not for ethics. When I started in the company my boss recognised my potential and promoted me to develop business systems and train staff all over Europe. After a happy and exciting time, my boss left. When I took over some of his responsibilities and reported directly to management, I started to comprehend the compromises he had been making. Stress quickly led to back and sleeping problems and chronic gastritis.

“After some months, I was selected to become a manager and sent to take a management course. Those four days turned out to be some of the most horrible days of my life. I was excited to join a group of what I thought were distinguished and ambitious future managers. However, I got some test results and feedback that did not match my thinking at all, that showed that I was different.

“When we worked on how to manipulate staff, I felt disgusted. I could not understand the discussions that we had on how to put pressure on teams to get the most out of them in terms of efficiency and productivity. I went home and, to the shock of my family and colleagues, I quit my job. And I started living again. I started studying coaching and organisational development from a psychological point of view to motivate and nurture staff in an ethical way, promoting self-efficacy. I followed Globethics.net’s online course on Ethics in Higher Education for Teaching Professionals. Finishing my studies opened a new world and a lot of opportunities for me all over the world. Since then I have been living, travelling and working happily and healthily ever after!”

This Annual Report 2019 reflects the journey that we are on together with our network of individuals and institutions dedicated to learning, research and exchange on ethics and to applying ethics.

The year 2019 was the 15th anniversary of the founding of Globethics.net and the third year of the focus on Ethics in Higher Education. During the year the Globethics.net Strategy 2019-2022, the new digital repository and the new logo and visual identity were launched. Events and projects were carried out successfully in India, Argentina, Jordan, Kenya, Ghana, Switzerland and Zambia among others. New members of the Globethics.net Consortium on Ethics in Higher Education were welcomed. A total of 31 new books were published, online courses were delivered and new courses developed. Ethics advocacy took place through speeches, workshops, training events and book launches. Our team was strengthened with new members, including our new Academic Dean.

The stories in this report are told by individuals from different countries and contexts. They are authors, students, teachers, project participants, library users and partners. Their stories show how their lives and work have been enriched and changed through our vision to embed ethics in higher education and our mission that is E.T.H.I.C.S.

“Ethics matters. This is my story”

“I am a Roman Catholic nun in an active religious order in Nigeria for the past 25 years. As community superior, headmistress, school matron, religious formator, principal, lecturer, spiritual director and adviser and as a student at different institutions, with training in human development, my life has been ethically transformed. In all these, added to my current ecumenical formation and above all, an encounter with Globethics.net, I have encountered values-driven people that challenge and encourage me ethically.

“The climax was my three-years’ experience as a principal at Mercy Girls’ Secondary School in the Catholic Diocese of Aba in Nigeria, a school known for zero-tolerance of examination malpractice. As principal I said an ethical ‘NO’ to corruption in the pursuit of moral and academic excellence. I was misunderstood, misrepresented and vehemently opposed from all angles by students, parents and staff. Some parents took their children out of the school and we faced financial challenges. However, I won, and the students that stayed scored 100% in their final examinations without cheating. Ethics cannot be sacrificed on the altar of any human or material gain.

“Experience has taught me that life is about values, discovered, spoken of, lived and died for. Values make life meaningful, and ethical values set us on the path to freedom of simply good, right, just and pure living. However, the ambivalence of human freedom makes values-driven lives difficult, throwing humans into confusion and tension. In this dilemma, ethics guides, mentors, and introduces us to principles of behavioural conduct, itself becoming a tool for navigating the storms of life. Discernment plays a vital role at such crossroads, thus confirming that our values inform our decisions. This is why ethics matters. This is my story; this defines me.”

Transforming Lives through Learning

The Globethics.net Academy provides courses for students as well as training and blended learning for higher education institution leaders, teachers and administrators. The Ethics in Higher Education for Teaching Professionals (EHE-TP) course was launched in 2018 on the Globethics.net Academy e-learning platform. By March 2020 more than 160 teaching professionals have taken part in the course. Through such online courses, training and blended learning the aim is to empower teachers, administrators and higher education managers to promote and integrate ethics in their curriculum, in their practice and in their

institutions more effectively.

In 2019, specific attention was given to developing courses on Interfaith Dialogue, Ethics for Administrators, Corporate Social Responsibility and Sustainable Development, and Responsible Leadership to be made available on the Globethics.net Academy in 2020 and 2021.

Members of the Globethics.net Consortium on Ethics in Higher Education have the opportunity to use the Globethics.net Academy as their e-learning platform for engagement with their students. Tailor made e-learning environments are being created together with partners with options for different levels of support in the design, upload and delivery of the courses.

In addition to the Globethics.net Academy courses and training, students and professionals benefit from the extensive resources available free of charge in the Globethics.net Library repository as well as from more than 200 Globethics.net Publications with the possibility to submit and publish their research and to share it with an international research community.

Transformation through Adaptation

Globethics.net is engaged to best serve the needs of its network members, partners and participants through exchange and joint activities. Globethics.net

has embarked on a process of positioning itself anew and of adapting its status and activities. The aim is to effect positive ethical change in society in general and in the higher education sector in particular.

Since 2018, Globethics.net identified being accredited as a higher education institution as a priority to be able to provide academic credits for courses that are recognized across the higher education sector.

With the support of UK NARIC, the aim is to obtain global recognition as a higher education institution of applied ethics. Through this worldwide recognition, Globethics.net’s course programme offer can be made more visible and attractive to participants.

At the same time, articulation agreements are planned to lead to more joint educational projects

with leading universities such as Leeds Beckett University in the UK, or the University of South Africa (UNISA).

Institution Building: with the appointment of the Academic Dean and the implementation of quality assurance standards according to the UK regulated qualifications framework, the formation of the Academic Committee and the preparations for recruitment of Faculty through the Pool of Experts, the academic procedures are now being put in place ready for the next move.

Catalogue of Products: the second edition of the catalogue was circulated in March 2019 to our network, and has been further disseminated through training workshops in South America, India, Russia, Southern Africa, Nigeria and China.

Key Achievements

- *Consortium:* the Globethics.net Consortium on Ethics in Higher Education has 17 institutional members, including universities and educational networks and 50 individual members. The Consortium held two meetings in 2019.
- *Training:* The Globethics.net team and members of the Pool of Experts delivered a series of capacity building workshops and lectures on ethics topics in different countries of the world in 2019. To date, 30 ethics experts covering a range of fields of expertise in applied ethics have been accredited as Globethics.net experts.
- *Online courses:* in 2019, four intakes of 40-50 participants each were organised. Course participants were provided with a wide range of learning content around ethical decision making and, through forum discussions and other engaging methodologies, were guided to carry

out an assessment of their own and their institutions' norms and values, and at the same time, to further profile their knowledge, competence and skills in ethics in higher education.

Globethics.net Offer: Key Strengths

- *Educational level and learning objectives:* the combination of onsite training of trainer courses, followed by an option to pursue with online training helps to keep costs down for participants and contributes to increased visibility and coherence of the educational offers in a blended-learning perspective. Relevance of topics thanks to high quality of research is the main strength of Globethics.net course on EHE-TP.
- *Learning resources and lecture materials:* the learning content covers a wide range of ethical issues affecting institutions of higher learning and is interesting to teaching staff. The Globethics.net Library and Publications offer

relevant learning resources in accompaniment of the course units and additional bibliographic references for further reading.

- *Assignments and learning activities:* assignments and learning activities are learning outcome-based and designed around interactive teaching methods such as discussion forums and case study analyses. The use of the Moodle learning management system allows an efficient monitoring of participants' learning progression and a quality-oriented evaluation of the assignments and learning activities. Accreditation of the course brings more value to participants through the credit transferable modules.
- *Distance learning and open education concept:* Globethics.net's online platform offers opportunities for learning and collaboration among institutions and teaching professionals in line with the trend to use Open Educational Resources. This is an important aspect for Globethics.net's efforts in democratising the access to higher education and in fostering global exchange on cutting-edge ethical topics.
- *Academic support:* the Globethics.net online platform offers opportunities for online learning and academic support based on specific learning outcomes and quality standards.
- *Unique selling point:* positive feedback on the relevance of this course for institutional and professional development in the area of applied ethics, gives Globethics.net a unique position in higher education.

The Way Forward: Learning and Improving

- *Educational level and learning objectives:* learning objectives being linked to practical assignments to enhance the relevance of courses for participants.
- *Learning resources and lecture materials:* updated reading material and more visibility of newer articles and books can be improved through establishing links to academic resource repositories.
- *Assignments and learning activities:* interaction in class to be improved by fixed weekly sessions as an integral part of the online course using video chats.

- *Design and online learning platform:* tutorials or a virtual tour around the platform, and videos to make the content more vibrant and engaging.
- *Support and teaching:* increased attention to participants' needs in their learning journey to augment participation during class and encourage completion of the courses.

Library

Transforming Lives through Knowledge

The Globethics.net Library is a free, open online library aimed at providing quality resources on applied ethics, education and religious studies from all over the world. Content in the Library is available in multiple languages and is harvested from more than 3,000 open access repositories. The Library's thematic and institutional collections have been developed with experts and partners. In addition documents are uploaded by individual Globethics.net participants, making the Library a unique resource for students, researchers and for all those interested in deepening

their knowledge.

The Library has been conceived to share and promote research and reflection on ethics among scholars, especially with and from the majority world, which often faces barriers to participation in the global dialogue on ethics because of a lack of access to knowledge resources. The Library currently holds more than 3.5 million documents, including articles, books, reference works, dissertations, conference proceedings, case studies, and educational resources, accessible free of charge, many in full text and via a multilingual portal.

Launch of New Library Repository

After a year of intensive preparations, the Globethics.net Library moved its multi-million strong database to a new platform (see <https://repository.globethics.net>), that was launched on 15 November 2019 (see www.globethics.net/-/the-new-globethics-net-library). The new Library system is cloud based and managed and developed together with Atmire NV in Belgium.

Technically, the new Library software DSpace offers many advantages:

- *Integrated, multi-layered repository solution*, including a back-end for storing the digital assets,

middle-ware components, with author profiles, a customizable submission workflow, integration of third party services, such as CrossRef, ORCID, Google Analytics, and Altmetrics, and a front-end user interface, that is user and mobile friendly, all in one single package.

- *Sustainability* in terms of software development and maintenance, which is fully included in the service contract with the provider.
- *Greater discoverability* on the Internet, for example through Google Scholar.
- *Open data sharing* through OAI-PMH and REST API endpoints. It is planned in 2020 to share our library data with OCLC WorldCat, the world leading library catalogue.

The new Library repository offers state-of-the-art functionalities to users and researchers with:

- Faceted search;
- Standard citation exports;
- Integration of ORCID (Open Researcher and Contributor Identifier); and
- Wide range of social media options for sharing.

A total of 3,863,192 items were migrated to the new Globethics.net Library repository including:

- 74 special collections (595,208 items);
- 141 journals (72,297 items); and
- OAI (open archives) data (3,195,687 items).

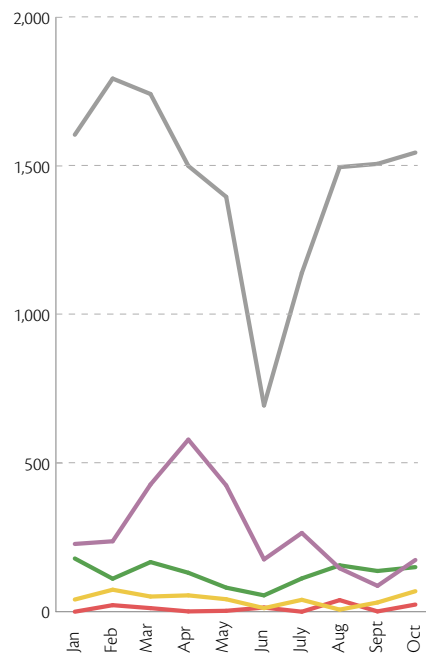

The Library features Globethics.net Publications and



other works by prominent authors, scholars and experts in the various fields related to ethics (see <https://repository.globethics.net/discover-authors>).

As a result of the new Library project, the Globethics.net Library homepage, www.globethics.net/library, has been re-designed and updated, to reflect this major upgrade, including the former homepage of the Global Digital Library on Theology and Ecumenism (GlobeTheoLib / GTL), which can still be accessed at www.globethics.net/gtl.

Special Projects

A cooperation agreement has been signed with the Macau Ricci Institute, to develop a digital collection. The collection is planned to feature items on the history of Jesuit missionaries and scholars in China, on Chinese wisdom traditions, such as Confucian ethics, as well as the Macau Ricci Institute journal, the Online Journal of Moral Leadership, Social Innovation and Comparative Spirituality.

A new collection on Asian Christianity and Theologies is being developed with the financial support of the Foundation for Theological Education in South East Asia (FTESEA). The new collection is available at <https://repository.globethics.net/handle/20.500.12424/79>.

Additional funding was received from FTESEA and from the Evangelisches Missionswerk Deutschland (EMW) in 2019 to support the Library.

Use of the Library

In the period January to October 2019 the total number of items downloaded by users from the Library was 18,981, an average of 1,898 per month.

Most of the items were downloaded by Library users in Europe (2,355 or 44% of the total), followed by Asia (1,386 or 25%) and Africa (396 or 13%).

With regards to the kinds of items that users were most interested in downloading, 51% of the items were curated sources from OAI (Open Archives Initiative) followed by 36% of items that were submitted to the Library by the Library team and by users.

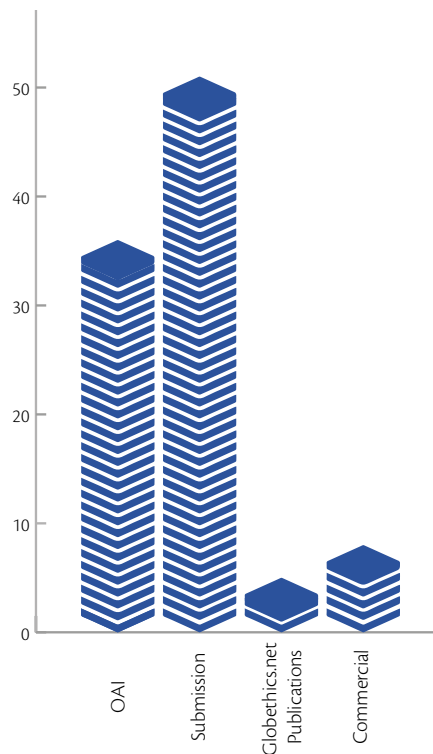
Use of the New Repository

Since the launch of the new Library system in mid-November until the end of the year, 2,949 users, coming mainly from

- the United States (764),
- Switzerland (314),
- Indonesia (232), and
- India (142),

viewed 10,478 collection pages. The 'Journals AtoZ' list, 'Theology and Ecumenism', 'Chinese Christianity', and 'Educational collections' were among the pages most viewed, followed by the 'Ethics in Higher Education' collection page with over 50 views.

From 15 November to the end of December 2019 a total of 741 full texts, including volumes among the Globethics.net Publications, such as 'Human Rights, Religious Freedom and Faces of Faith' (91 times), 'Higher Education in Crisis' (16 times), and 'Blue Ethics: Ethical Perspectives on Sustainable, Fair Water Use and Management' (10 times) were among the most downloaded texts.

Transforming Lives through Exchange and Research

Globethics.net Publications has continued to expand its broad collection of literature on ethics, theology and philosophy. In 2019, over 8,500 pages were published, in 31 books across 18 series and in six different languages.

Four new series were created by Globethics.net Publications in 2019.

- *Education Praxis Series*: books in this series highlight concrete methods that enable readers to adopt a practical approach to ethical dilemmas.
- *Philosophy Series*: provides the opportunity for

readers to deepen their understanding of the works of important philosophers, through the unique insights of each author.

- *Ethical Sieve Series*: each volume in this series is the result of an essay competition on applied ethics. The name of this series, the 'ethical sieve', is a metaphor for the selective process used for each essay that is featured.
- *Paideia Series*: the focus of this series is on education, its structures, institutional support in developing countries, educational cooperation and the promotion of children's rights.

- workshop in Nairobi, Kenya in May 2019 and two workshops on Strengthening Assets Management and Ethical Investment Capacities in Accra, Ghana (13-14 November) and Lusaka, Zambia (19-20 November), are planned for release in 2020;
- Launch of the publication ‘Mainstreaming Ethics in Higher Education’ on 11-12 November 2019. The launch was organised by the Catholic University of Eastern Africa (CUEA), which held an international conference in 2018 on the theme ‘Preparing Ethical Professionals through Higher Education’ at the University’s Lang’ata Campus in Nairobi, Kenya. ‘Mainstreaming Ethics in Higher Education’, which showcases the outcomes and research following the 2018 conference, is the largest book to date with 779 pages;
- Globethics.net released its first co-publication with the Observatoire de la Finance, a Geneva-based think tank that makes the link between financial practices and the demands of the common good. The co-publication, entitled ‘Changing Frontiers of Ethics in Finance’ (published in the Ethical Sieve series), is a selection of essays submitted for the The Ethics and Trust in Finance Prize (2012-2017);
- On 28 October 2019 Globethics.net organised the launch of two books: ‘Water Ethics: Principles and Guidelines’ and ‘Blue Ethics: Ethical Perspectives on Sustainable, Fair Water Resources Use and Management’. Dr Benoît Girardin, Lecturer at the Geneva School of Diplomacy and International Relations as co-editor of both publications, was invited to present his work. Dr Girardin presented

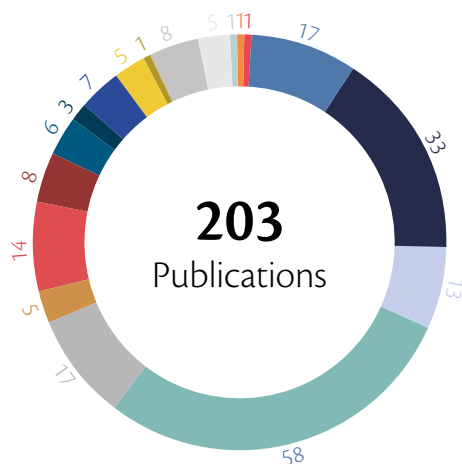

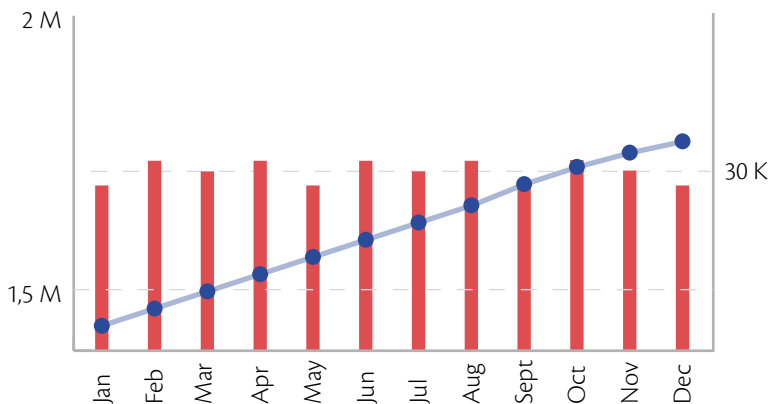

- 'Ética y Economía' vol. 2 will be released in 2020, an important work from the Globethics.net South-America Regional Programme;
- Different books on international business ethics from the Chinese perspective are planned in 2020; and
- Publications Manager, Dr Haaz, will present on the topic of mental health ethics at the Swiss Alternative Medicine international conference set to take place in September 2020, where he will present his new book on 'Empathy and Indifference', in the Philosophy Series.

Access to knowledge and quality information is one of the keys to a decent education. For more than 15 years Globethics.net has been working in this direction, empowering participants interested in ethics and applied ethics with quality and reliable information on ethics.

An Engaged Online Network

Globethics.net, as an online network, uses its website as the primary vehicle to share information and connect the network of registered participants. During 2019, the average number of visitors per month was 5,143 users, 24.7% of whom were returning visitors.

The Library, Publications and the Academy were the pages consulted most by users in 2019. In 2018 and 2019 Globethics.net promoted the online course on Ethics in Higher Education for Teaching Professionals, with the result that the interest of users placed the course page among the most viewed pages on the website and the second most viewed page among the Academy web pages. Website data on page visits shows the users' particular interest in accessing educational and reference resources to develop their knowledge and skills with regards to ethics.

Awareness Raising about Ethics

In addition to the website, Globethics.net uses social media to share its message and information with the wider public. Present on Twitter, Facebook, LinkedIn, Youtube and Flickr with more than 11,336 followers in total, Globethics.net uses the social media platforms for the purpose of disseminating quality content and of promoting its activities or those of its network. For this reason, it regularly shares content, such as the book of the month, selected by Globethics.net librarians, its events or its latest publications through social media.

As an organisation in consultative status with the United Nations Economic and Social Council (UN ECOSOC), Globethics.net follows and supports the international days set by the United Nations, adding

an ethical dimension to the discourse by disseminating views and resources on the different themes.

Although Globethics.net is mainly an online platform and uses its website to disseminate information, it works closely with its regional programmes in advocacy activities. Together they organise events to showcase the need for change in the educational system to integrate ethics in the educational environment, to provide the students with the tools, guidance and context to develop critical thinking.

Events and Activities

In 2019 Globethics.net conducted around 15 events and took part in more than a dozen events around the world. In 2018 Globethics.net concentrated its activities mainly in Africa. Although in 2019, Africa was still one of the main venues, there

were also activities in India, Latin America and in Europe.

After the international workshop held in August in Geneva, Switzerland, to which Regional Programme representatives and National Contacts were invited along with university vice-chancellors, new activities emerged. One example was an invitation from The House of Ethics in Jordan to Globethics.net to help to develop a code of ethics.

In September 2019, Globethics.net went to Jordan and made several interventions: one, a workshop in Amman to start to develop the Code of Ethics for The House of Ethics; and the second one, with the American University of Madaba to close an agreement for collaboration and start organising a training of teachers workshop.

discuss and address the needs for ethics in governance and for values-driven leaders in the country and in the region as a whole.

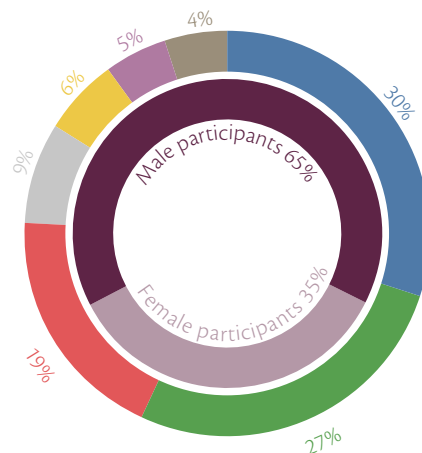
Globethics.net India organised a series of events with partners. For example, the consultation in December 2019 at the Loyola College of Chennai, was a follow-up from the National Conference on Ethics in Higher Education at the Agnes Martin Hall in Madras Christian College, Tambaram, Chennai in 2018. The aim of the conference was to deepen the discussion on the integration of ethics in the Indian education structure and institutions and to bring out a book that will be available for all Indian universities, colleges and institutions to use.

Global Ethics Day

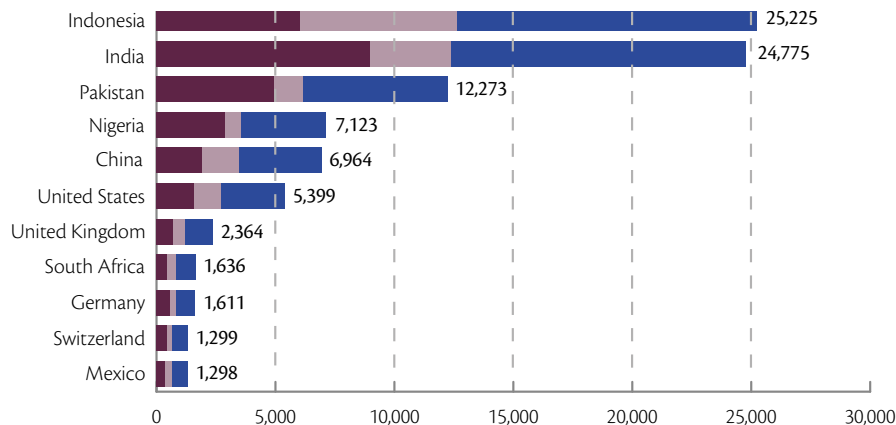

Academic Partners

Currently, there are 282 higher education institutions (universities, seminaries, theological centres, libraries, academic institutions and umbrella organisations engaged in education) that have signed partnership agreements with Globethics.net., including 17 Consortium members.  - *Inclusion/Fairness*: we work to overcome exclusion and to recognise equality, justice and fairness for all.

- *We provide professions* with educational materials adapted to their profession to grow a deeper understanding of ethics in their context (for them to use to practice ethics)
 - *We encourage students* to behave ethically, showing them best practices of individuals, companies and organisations that have become successful by following ethical standards and principles
 - *We contribute* to achieving the United Nations Sustainable Development Goals.
