The objectives of the meeting were to examine the ethical basis of regulations for scientific research in medicine and social sciences related to health. Written rules and regulatory procedures in various countries were compared and analysed. The meeting concluded with recommendations for the work of the Pan American Health Organization (PAHO) in the Region of the Americas and the Caribbean.

The program included both lectures and discussion seminars, attended by 120 professionals, thirty of whom were foreign guests. Simultaneous translation English-Spanish was provided and the proceedings were transmitted by webcast. All lectures and discussions were recorded.

Press coverage was moderate, since it was defined as a working meeting of the Pan American Health Organization itself without breaking stories of controversial issues. However, it coincided with the outbreak of swine influenza that captured the attention of the media.

The main outcome of the meeting was to strengthen the guiding role of the PAHO Bioethics Program on for discussions pertaining to the moral foundations that legislators and drafters of written rules take into account when preparing texts. Sometimes the ethical directives are explicit, but sometimes they are more inspirational for the reflection and analysis needed to assess their importance and influence. Conferences delivered at the meeting will be published in a supplement of the journal *Acta Bioethica* and available on a DVD that will be distributed to interested parties.

After the congress, a meeting of all Collaborating Centers in Bioethics of the World Health Organization was held. Attended by delegates from the centers of Canberra, Toronto, Miami, and Santiago, with connections to Paris and Zurich at that meeting, the first of its kind, a network of partners was established that will enhance the work of each by a synergy that allows resources to be shared.
